## RULES & REGULATIONS

#### PARTICIPATION

Application for participation is to be made in prescribed form. Acceptance and exhibits will be at the sole discretion of the Organisers.

- Stalls will be allotted on a first-come basis only on receipt of completed application form along with requisite payment.
- · Allotment of stalls will be made at the discretion of the Organisers.
- Subletting of stall(s) or displaying products not covered by original application will not be allowed.

#### STALL ALTERATION

- No alteration of size and position of the exhibitor's stall is permitted without the prior written approval of the Organisers.
- . The Organisers reserve the right to modify the layouts of stalls and gangways.
- The Organisers reserve the right to request the Exhibitors to make such alteration of their stalls as to setting of exhibits, as they reasonably feel necessary, to maintain an acceptable standard of presentation or to avoid interference with the display of the other Exhibitors.
- Conversion of the allocated shall scheme site to Free Design is not permitted.
- While reasonable fixings may be made to the flush plywood walls of the shell scheme at the expense of the Exhibitor or his agent, no major alterations will be permitted.
- Stalls may not overhang the allotted area, nor any obstruction will be permitted on gangways, fire points, extinguishers or emergency exit.
- Exhibitors will not be allowed to use passage / other space at the venue for constructing and painting work.

#### STALL INTERIORS

While the Exhibitors are free to decorate their stalls they should not cause any permanent damages to the walls, panels and floors through use of nails, painting or any such activity.

#### **DEFAULT ON PAYMENT**

The Organisers reserve the right to cancel any reservations of space in the event of an Exhibitor not having paid the dues of rental charges as stipulated in the brochure. Payments already received will be forfeited in such cases.

#### POSSESSION OF STALL

Possession of stall will be given only on receipt of full payment including payment for extra requirements.

#### SPACE NOT OCCUPIED

- · Every Exhibitors shall occupy the full stall area booked.
- Should Exhibitors fail to take the stall allocated to him, Organisers reserve the right to deal with the stall so unoccupied as they think
  appropriate.

#### NO SUB-LETTING

- The Exhibitors may not assign, sub-let or grant licence of the whole or any part of the stall.
- Cards, advertisements or printed matter of persons or firms that are not bonafide Exhibitors will not be exhibited or distributed from any stall except on Exhibitor may distribute cards, advertisement or printed matter in respect of companies or firms which are subsidiaries of Exhibitors ultimate holding company.

#### **OPERATION OF STALL**

- No stall will be left unattended during the exhibition. Staff of Exhibitors must be present at least one hour before the opening and half an hour after the close of the exhibition
- A maximum of two members of the Exhibitor's staff will be permitted at the stall. Exhibitor badges given by the Organisers must be worn by such personnel during the Exhibition.
- No activity, which in opinion of organisers, amounts to nuisances or annoyance will be caused by the Exhibitors. The Organisers shall have the right to take remedial action in such cases.

#### VACATION OF SPACE

Space will have to be vacated by 9 p.m on the last day of the exhibition, failing which the Exhibitor will be required to pay a penalty as prescribed by the Organisers and they will have the right to remove the exhibits, material etc., of Exhibitors, at the risk and cost of the Exhibitor. **SECURITY** 

Although 24 hour security service will be in operation throughout the Exhibition, Exhibitors should take all possible precautions to minimise loss or damage to the equipment outside of exhibition timings.

#### **ELECTRICAL INSTALLATION**

All on-site electrical installation must be carried out by the officially appointed electrical contractor before connection to the main supply.

#### INSURANCE

Insurance of the exhibits and the property of the stalls will be the responsibility of the individual Exhibitors. The organiser shall not be responsible in any way for personal injury to the Exhibitor or his staff, invitees or licenses, however caused.

#### FAILURE OF SERVICE

The Organisers will use their best endeavours to ensure supply or services of the hall and official contractors, but as the supply of such services are not within the control of the hall and contractors, neither they nor the Organisers shall incur any liability to the Exhibitors for any loss or damage, if any service shall wholly or partly fail cease to be available. Nor shall the Exhibitor be entitled to any allowance is respect of rental due or paid under the contract.

### CONSEQUENTIAL LOSS

Incase of the Exhibition being cancelled or suspended in whole or in part for causes not in the Organisers control, the Organisers do not accept any consequential liability to retain the right to change the Exhibition dates/venues or cancel the Exhibition if in their opinion there is necessary cause for the same.

#### INTERPRETATION

The decision of the Organisers or nominee shall be final and binding on the Exhibitor on the interpretation of rules and regulations.
