RULES & REGULATIONS

PARTICIPATION

Application for participation is to be made in prescribed form. Acceptance and exhibits will be at sole discretion of the Organisers.

- Stall will be allotted on a first-come basis only on receipt of completed form along with requisite payment.
- Allotment of stall will be made at the discretion of the Organisers.
- Subletting of stall(s) or displaying products not covered by original application will not be allowed.

STALL ALTERATION

- No alteration of size and position of the exhibitor's stall is permitted without the prior written approval of the Organiser.
- The Organiser reserved the right to modify the layouts of stall and gangways
- The Organiser reserved the right to request the exhibitors to make such alteration of their stalls as to setting of exhibits, as they reasonably feel necessary, to maintain an acceptable standard of presentation or to avoid interference with the display of the other Exhibitors.
- Conversion of the allocated stall scheme site to free design is not permitted.
- While reasonable fixings may be made to the flush plywood walls of the shell scheme at the expense of the Exhibitor or his agent, no major alteration will be permitted.
- Stalls may not overhang the allotted area, nor any obstruction will be permitted on gangways, fire points, extinguishers or emergency exit.
- Exhibitors will not be allowed to use passage / other space at the venues for constructing and painting work

STALL INTERIORS

While the Exhibitors are free to decorate their stalls they should not cause any permanent damages to the walls, panels and floors through use of nails, painting or any such activity.

DEFAULT ON PAYMENT

The Organiser's reserve the right to cancel any reservation of space in the event of an Exhibitor not having paid the dues of rental charges as stipulated in the brochures. Payment already received will be forfeited in such cases.

All disputes are subjected to the exclusive jurisdiction of contempt courts and forum in Bangalore only.

POSSESSION OF STALL

Possession of stall will be given only on receipt of full payment including payment for extra requirements.

SPACE NOT OCCUPIED

- Every exhibitors shall occupy the full stall area booked.
- Should exhibitors fail to take the stall allocated to him, Organisers reserve the right to deal with the stall unoccupied as they think appropriate.

NO SUB-LETTING

- The Exhibitors may not assign, sub-let or grant licence of the whole or any part of the stall.
- Card, advertisement or printed matter of persons or firms that are not bonafide Exhibitors will not be exhibited or distributed from any stall except on exhibitors may distribute cards, advertisement or printed matter in respect of companies or firms which are subsidiaries of exhibitors ultimate holding company.

OPERATION OF STALL

- No stall will be left unattended during the Exhibition. Staff of Exhibitors must be present at least one hour before the opening and half an hour after the close of the exhibition.
- A maximum of two members of the exhibitor's staff will be permitted at the stall. Exhibitor badges given by the organizers must be worn by such personnel during the exhibition.
- No activity, which in opinion of organiser, amount to nuisances or annoyance will be caused by the exhibitors. The organiser shall have the right to take remedial action in such cases.

VACATION OF SPACE

Space will have to be vacated by 9p.m on the last day of the exhibition, failing which the Exhibitors will be required to pay a penalty as prescribed by the organiser and they will have the right to remove the exhibits, material, etc of Exhibitors, at the risk and cost of the exhibitors.

SECURITY

Although 24 hour security service will be in operation throughout the exhibition, exhibitors should take all possible precautions to minimise loss or damage to the equipment outside of exhibition timings.

ELECTRICAL INSTALLATION

All on-site electrical installation must be carried out by the officially appointed electrical contractor before connection to the main supply.

INSURANCE

Insurance of the exhibits and the property of the stalls will be the responsibility of the individual Exhibitors. The organizer shall not be responsible in any way for personal injury to the Exhibitor or his staff, invitees or licensees, however caused.

FAILURE OF SERVICE

The organisers will use their best endeavor to ensure supply or service of the hall and official contractors, but as the supply of such service are not within the control of the hall and contractors, neither they nor the organiser shall incur any liability to the exhibitors for any loss or damage, if any service shall wholly or partly fail cease to be available. Nor shall the exhibitor be entitled to any allowance in respect of rental due or paid under the contract.

CONSEQUENTIAL LOSS

In case of the exhibition being cancelled or suspended in whole or in part for causes not in the Organisers control, the organiser do not accept any consequential liability to retain the right to change the Exhibition dates/ venues or cancel the exhibition if in their opinion there is necessary cause for the same.

INTERPRETATION

The decision of the organiser or nominee shall be final and binding on the exhibitors on the interpretation of rules and regulations.

RIGHTS

The decision of the organiser reserve all right in connection to the Gruha Shobhe -2012-13

TERM OF REFERENCE

In these rules & regulations, the term 'Exhibitor' shall include all employees, staff and agents of any company; partnership firm or individual to whom stall has been allocated for the purpose of participating the Gruha Shobhe-2012-13
